#### **Host Club**

North Flathead Yacht Club, Somers, Montana will be the host club and organizing authority for the District 22 Laser Championship, to be held August 21<sup>st</sup> through August 22<sup>nd</sup>, 2010. See attachment A for location of the yacht club.

#### **Rules**

The regatta will be governed by the current edition of the Racing Rules of Sailing (RRS), the prescriptions of the United States Sailing Association (US SAILING), the rules of the International Laser Class Association (ILCA) and this Notice Of Race, except as amended by the Sailing Instructions or any appendices to the Sailing Instructions.

## **Eligibility and Entry**

All Laser sailboats and Laser sailors are welcome. No master's categories will be acknowledged. Rigs may be swapped (Radial to Full and back) at anytime (on land only) throughout the event. All sails must have the same sail number if swapping between Radial and Full rig.

Laser sailors may enter by completing the attached form and sending it, together with the required fee, to North Flathead Yacht Club, P.O. Box 208, Somers, Montana 59932 by August 14, 2010. Late entries will be accepted at a higher fee until the day of the race.


